This year, our largest area of programming was Youth and Education. Through our Early Childhood Education initiative, we've transformed the quality of local early childhood education in our community by providing intensive HighScope training, mentoring, and materials to hundreds of local teachers in our Head Start program and dozens of other early childhood education centers. We've expanded our education outreach and programming to include kindergarten and first-grade students, using the nationally recognized Responsive Classroom program. Also, we have more than 60 scholarship funds-many of which honor the memory of loved ones and community leaders, turning grief into tribute-that assist low-income students, provide valued-added internship opportunities, or train medical professionals, teachers, or engineers. Through these efforts, we hope to build a stronger future for our community by ensuring that its youngest members receive the support they need to grow into informed, involved, active citizens.

The Community Foundation of St. Joseph County's second largest program area is Health and Human Services. This area includes major grants to dozens of area social service agencies, including the Center for Hospice Care, which improves quality of life for those diagnosed with terminal illnesses and their families; the CASIE Center, which provides court advocacy and other services for children who have been the victims of sexual abuse, physical abuse, or neglect; Hope Ministries, which provides food and shelter, personal development and education, addictions counseling, transitional housing, and other support to hundreds of clients each year through its "wound care" model; LOGAN, which serves our community's mentally disabled population and also works with children with autism spectrum disorders; and dozens of other organizations that, through their good work, make our community a better place to live. We know that our community is only as strong as its individual components, and through these efforts, we hope to help the most vulnerable among us be safe, healthy, and well served.

Arts and Culture makes up the Community Foundation of St. Joseph County's third largest program area. Our community is brimming with artistic talent-talent that drives economic growth, providing jobs for our citizens and encouraging businesses to relocate to our community. We support that talent through our Arts Everywhere initiative, which includes grants to arts organizations such as the South Bend Symphony Orchestra, the History Museum, the Music Village, South Bend Civic Theatre, the Fischhoff National Chamber Music Competition, and the South Bend Museum of Art; an annual public performing arts series that features our communities most inspiring arts talent, and regular convening of local arts administrators. The Community Foundation believes in the power of the arts to educate, engage, and inspire local citizens, making our community a better place to live as a result.
