Delta College Foundation worked in collaboration with San Joaquin Delta College to facilitate Passport to College program which targeted more than 12,000 fifth grade students enrolled in public schools within the College's services area in 2006-07. The program implemented college fee waivers for the period from fall 2014 through spring 2017. Over 1,700 students have attended Delta College through the Passport to College program. In comparison to their peers, Passport to College students showed greater persistence rates, units attempted & completed, cumulatively completed almost twice as many units, had an eight percent higher three-year graduation rate while working on degrees and certificates. Foundation has several councils under Athletics, Student Chef, Fashion & Design and other programs that help students acquire necessary skills and knowledge and to provide additional funding to students for such activities as student field trips, supplies, equipment, stipends, scholarships, etc. Over 450 student-athletes participated in Delta Athletic team classes & practices with 345 completing a season of competition. There were over 70 employees and volunteers working in the Delta athletic department in 2016. Culinary Arts division has a council with different programs such as Student Chef, Winter Buffet, Bakers program and others that help to prepare students for employment in the hospitality industry as culinarian, baker, food service manager. The programs help to enable students to complete competencies in food production, service, sanitation and food safety, baking, nutrition, management, purchasing, culinary arts technology, menu planning, beverage management. More than 50 students participated in various culinary activities during the year that helped raise funds for various student activities, supplies and equipment.
