Each Board member is required to complete a conflict of interest form at the September board meeting. These are gathered by the President's Office with copies sent to the Internal Auditor. The Internal Auditor then analyzes the disclosures made with the assistance of the Controller and Vice President for Finance and Administration and prepares a summary of any relationships disclosed. All employees are required to sign a conflict of interest form upon hire. If any relationships are disclosed, a copy of the form is sent to and analyzed by the Internal Auditor. Key employees are required to complete an updated form annually. In May of each year, the list of key employees is analyzed and updated as necessary by the Internal Auditor with the assistance of the Vice President for Finance and Administration. In December of each year the forms are sent to the individuals identified as key employees. The completed forms are then analyzed by the Internal Auditor, Controller and Vice President for Finance and Administration and a summary is prepared of any relationships disclosed. Both summaries are then presented to the Audit Subcommittee of the Board of Trustees at the February Board meeting.
