Infants/Toddlers/Early Head Start/Elementary School-Age Programs CDC provides full-day, year-around child care and early childhood education for children up to their third birthday. A nutritious, age-appropriate breakfast, lunch and snack are provided. The organization's Early Head Start program offers additional benefits for working, income-eligible families, including periodic home visits, access to high-quality health care services, and services for expectant mothers before and after they give birth. During the year ending June 30, 2017, CDC provided care for about 150 children in this age group. For children from kindergarten through sixth grade, CDC provides a safe, fun setting before and after school. A healthy breakfast and after-school snack are provided on school days, along with engaging hands-on math, science, art and other activities, and homework help. When school is out for summer, CDC's Camp Funshine provides a safe, fun, educational break until classes resume in the fall. During the past fiscal year, CDC served 200 elementary school-age children.
