Family Care Services- Primary care is the largest segment of PHMS, comprising 42% of the total program expenses of PinnacleHealth Medical Services. Primary care services are currently provided through 23 family care centers located in surrounding central Pennsylvania communities. During the fiscal year ended June 30, 2017, primary care patient visits totaled 367,752, of which 24,683 were due to three new family care practices: Family Care Spring Road, Fisher Road Family practice, and Chambers Hill Family Practice, are three full-service primary care practices which joined PinnacleHealth Medical Services in fiscal year 2017. The addition of these primary care locations supports PinnacleHealth's local focus and commitment to the community while giving patients increased access to the PinnacleHealth family for specialty care and advanced technology for diagnosis and treatment.

**Form 990, Part III, Line 4c:**

Pinnacle Health Clinics - The clinics comprise 8% of the total program expenses of PHMS. There are 6 clinic facilities throughout Central Pennsylvania that provide patient care to the surrounding communities. During the fiscal year ended June 30, 2017, clinics had visits that totaled 56,176. The clinics mainly serve an un-insured, under-insured, and large medical assistance community, as living out its mission statement to be a charitable organization dedicated to maintaining and improving the health and quality of life. The clinics include the following:

- Kline Health Center - This program provides primary and specialty care to a largely urban population. While the practice does see private patients, much of the population served is of low income and/or underinsured. Since many of our patients rely on public transportation, Kline is able to meet many of the patient's needs at one location. Resident physicians, under the supervision of board certified physician faculty as well as specialty physicians, come to Kline to see patients for their orthopedic, endocrine, neurological, infectious disease, and surgical needs. The office is managed by a full-time RN who oversees a staff of medical assistants and other office support staff to meet the needs of the patients and providers.
- Children's and Teen Center - This program provides primary, acute, and preventative care plus some specialty services for children newborn through 18 years of age. Specialty services include neonatal developmental care, lead poisoning diagnosis and follow-up, pediatric neurology, and care for children infected with HIV.
- Women's Inpatient Services - This program provides comprehensive inpatient obstetrical and gynecological services to a patient population consisting largely of a managed care medical assistance patient base. This program was established in 2007.
- Women's Outpatient Health Center - This program provides comprehensive outpatient obstetrical and gynecological services to a largely managed care medical assistance patient population.
- PH Resource Education and Comprehensive Care for HIV (REACCH) - This program was established to provide primary and specialty medical care for people (including pregnant women and their exposed infants) who are HIV-positive as well as provide support services for these patients. Additional services provided to this patient population include nutritional counseling, transportation to medical appointments, vision care, assistance with medication co-payments, and assistance with mental health counseling and psychiatric care. The program is partially grant funded and also provides reimbursement to Pinnacle Health System for services rendered to patients who are HIV-positive and are either uninsured or underinsured.

FastCare Retail clinic sites are the smallest portion of PHMS, consisting of 3% of the total program expenses in 2017. As part of our mission to provide access to care and to accommodate those patients who need care at times when our primary care offices cannot assist them, two additional Retail Clinics opened in Lebanon and Lemoyne in fiscal year 2017. With access to patients' medical records from their recent primary care visits, the clinics provide seamless follow up care. The Retail Clinics are open seven days a week with evening hours and no appointments are necessary. Total patient visits were 32,210 at the five sites.
