Barrett Hospital & HealthCare offers low cost wellness programs (e.g. weight loss, lab screenings, student-athlete sports physicals) to the community, is an active community emergency preparedness partner, provides trauma prevention education, and partners with the county Public Health Director and community organizations (e.g. YMCA) on community wellness initiatives. Barrett Hospital & HealthCare sponsors the local Cancer Support Community gatherings and maintains over a mile of walking trails on the campus grounds for community member use. Barrett Hospital & HealthCare subsidizes the Home Health and Hospice programs for the community and partners with local volunteer EMS services and law enforcement to provide education and training. Barrett Hospital & HealthCare participates in government sponsored health programs including Medicare, Medicaid, CHIP, Veteran's Affairs, and Tricare. Barrett Hospital & HealthCare relies on community involvement to help keep in touch with the current needs of the community. Barrett Hospital & HealthCare has a 5 member board of trustees. The members of the board are publicly elected residents of Beaverhead County. In addition, Barrett Hospital has a large volunteer program. Approximately 80 volunteers contribute their time and efforts to the hospital. The hospital also relies on community members for various advisory councils including the Patient Advisory Council. Barrett Hospital & HealthCare is the only hospital in Beaverhead County. Medical staff privileges in the hospital are open to all qualified physicians and providers. Barrett Hospital operates an emergency room that is accessible to anyone needing care regardless of their ability to pay. The emergency room has approximately 4,500 visits annually.

ENT (ear/nose/throat) Services were also identified as a service need by the community. Barrett Hospital previously has been involved in an unsuccessful regional partnership with an ENT. Barrett Hospital is unable to support having a full-time ENT specialist based on need for services. CHNA respondents indicated they did not get or had to delay getting needed healthcare services. Top reasons for delaying or not receiving needed healthcare services were: It cost too much, my insurance didn't cover it, and wait was too long for an appointment. Barrett Hospital conducts continuous reviews of their pricing to remain competitive with the current market. The hospital is involved in various cost savings initiatives to reduce their costs and the cost of care for our patients. The hospital will continue to work with our insurance partners to offer education to the community regarding insurance coverage whenever possible. Barrett Hospital & HealthCare is committed to providing high value healthcare and services for our community. As an organization, we make every effort to develop relationships with a broad range of collaborative partners within our community and neighboring communities to improve the quality of care and services available to our patients. Barrett Hospital's Leadership Council and Board of Trustees evaluate the facility's ability to meet the needs of the community through our strategic and operational plans.
