Cypress Ranch Theatre presented six primary theatrical productions (Hello Dolly, A Piece of My Heart, Epic Proportions, A Chorus Line, Peter and the Star Catcher, and School Daze), Jr. Thespian and hosted multiple matches for Comedy Sportz High School League. Expenses included costumes, make-up, musical direction fees, publicity, royalties, sets, sound, staging, props, scripts, technical assistant fees, and miscellaneous supplies.

Revenue from education trips includes student payments towards their expenses and Cypress Fairbanks Independent School District reimbursement for 1/2 of registration fees for the National Thespian Festival. CyRanch Theatre had 51 students compete and qualify at the State Thespian Festival in Dallas, Texas in December 2016. In June 2016, these students traveled to the National Thespian Festival held at The University of Nebraska in Lincoln, Nebraska. Expenses include transportation, lodging, registration, and competition fees.

Purchase of necessary replacement and/or new equipment and tools for the Cypress Ranch High School Theatre Arts Department to provide for continued high-quality theatrical productions for the benefit Cypress Ranch theatre students and families, as well as our Cypress, TX community. Key purchases this year included six vertical rolling mirrors (each 60"x96"x1.25"), costume racks, nine mics, bodypack, 2 cyber power PFC Sinewave UPS towers, four Ushio spotlight lamps, and equipment to build the sets.
