The Clown: Kemp's Jig. In recognition of the 400th anniversary of Shakespeare's death, the Newberry Consort presented a concert based on William Kemp, the clown of Shakespeare's company and famous in his own right. The concert presented three of the Jigs Kemp would have performed during intermissions or at the end of Shakespeare's plays. The costumed performers took various roles, including that of Kemp himself, and performed the jigs based on the original scripts and period music.

4b (Code: 711130) (Expenses \$ 20,968 including grants of \$) (Revenue \$ 12,348)

The Count: Music of Oswald von Wolkenstein. Oswald von Wolkenstein (1376 - 1445) was at various times a soldier, diplomat, musician, monk, and a shipwreck survivor. The concert consisted of selections from some one hundred and thirty songs that recounted the life, experiences and travels of Wolkenstein's varied life and times. This was enhanced by visuals taken from the illustrations in manuscripts containing his music.

4c (Code: 711130) (Expenses \$ 28,227 including grants of \$) (Revenue \$ 14,718)

The Queen: Christina of Sweden. Christina became queen of Sweden at age 6 when her father was killed in battle and abdicated her throne for religious reasons, traveling throughout Europe while settling in Rome. She was friends with Descartes, Bellini, several cardinals and popes and many famous musicians. The concert consisted of works written about and for Christina and her family as well as music she would have heard and enjoyed. In addition to projected illustrations, the concert included narrations read from Christina's diary.
