KNOM exists to broadcast faith, inspiration, news and education to listeners in remote Western Alaska. This mission is steeped in the values of KNOM: to be a friend and companion, provide respectful service, and honors Catholic ideals. KNOM's listeners (numbering 20,000-30,000 people) are spread across 100,000 square miles. Most live in villages along the Bering Sea Coast and eastward to the Alaskan Interior. KNOM has calculated that \$100,646 is the amount of in-kind labor provided by volunteers.

4b (Code) (Expenses \$ 60,564. including grants of \$ 0.) (Revenue \$ 54,225.)

The digital studios were completed this fiscal year, with dedication on October 1, 2016. The final phase of the million dollar campaign began in January, 2017 - replacement of the 20 year old AM transmitter. Projected cost of the new Nautel ND25 transmitter is approximately \$90,000 plus installation costs. If funding is secured, hopes are for a fall 2018 install. \$54,225 was raised in FY 2017 for this multi-year campaign. \$103,682 has been spent in capitalized costs in FY 2017.

KNOM continues to serve the people of Western Alaska. As internet become more available to the remote regions of Western Alaska, listeners and supporters can now accessing KNOM's productions (including holy Mass, prayers, inspirational and local programming, news and education, with emphasis on Native culture) from the radio signal and online. Still, with internet access still cost prohibitive for most of KNOM's listeners, radio transmission remains the primary means of ministry.
