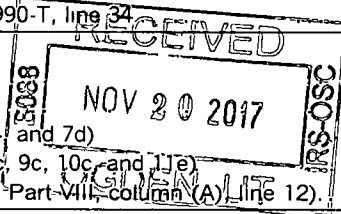

In FISCAL 2017:

- Clients increased by 40%, and twice as many clients were registered from under-served communities. The number of Spanish-speaking clients increased by 50%
- We were able to train our Bilingual Client Liaisons in the benefits of healthy eating by creating an Client Liaison information packet on the composition of our meals.
- Partnering with local chefs, we were able to discuss and restructure recipes to be more culturally relevant to Latinos, offering spices, vegetables, and compositions of meals that are familiar while keeping with our food values of utilizing fresh, organic ingredients that are unprocessed and focused on fresh vegetables and healthy, low-fat proteins.
- 110 teens served a total of 4162 service learning hours, an average of 104 hours per week of donated service learning hours.
- Over 24% of teen chefs received their green monogrammed aprons, honoring their service in the kitchen. 85% of teen chefs, as determined by pre and post surveys reported more confidence with preparing meals from scratch.
