During the fiscal year, AIE - LA delivered 15 weeks of Summer Camps to approximately 150 high school students. AIE - LA in collaboration with Louisiana State University (LSU), University of Louisiana - Lafayette (ULL), and Delgado Community College made these camps available to students entering grades 9 through 12. Summer Camp is geared toward high school students seeking knowledge in 3D animation and computer programming for video games. Camps are one week in length and promote school exposure to the community it serves, and is an introduction to courses students will enjoy at the college level. Successful Summer Camps are important to the school's purpose and mission as they are often the first contact students have with the school and its staff.
