MIRACLEFEET INCREASES ACCESS TO PROPER TREATMENT FOR CHILDREN BORN WITH CLUBFOOT IN DEVELOPING COUNTRIES THROUGH PARTNERSHIPS WITH LOCAL HEALTHCARE PROVIDERS. MIRACLEFEET-SUPPORTED PARTNERS DELIVER HIGH-QUALITY CLUBFOOT TREATMENT WITHIN EXISTING PUBLIC HEALTH SYSTEMS FOR ALL CHILDREN IN NEED. BY PROVIDING ORGANIZATIONAL, TECHNICAL, AND FINANCIAL SUPPORT, MIRACLEFEET ENABLES ITS PARTNERS TO FULLY TREAT CHILDREN BORN WITH CLUBFOOT IN LOW AND MIDDLE-INCOME COUNTRIES. THE AVERAGE COST TO DELIVER LIFE-TRANSFORMING TREATMENT IS \$250 A CHILD AND IS FREE OR EXTREMELY LOW-COST FOR THE FAMILIES WHO RECEIVE IT.
