also supports local-level advocacy efforts by ACS Chapters in their respective states by offering grants between \$5,000 and \$15,000 through their Chapter Lobby Grant Program. The

chapters conduct state capital lobby days in which fellows, residents, and members of the ACS participate in state lobby days to advocate for legislation that will improve patient safety

and quality, and to educate lawmakers about their chapter's legislative priorities. This year, the ACS launched a Chapter Advocacy Initiative Pilot Program, which carries a larger grant of

15,000. It was made available to the Georgia Society of the American College of Surgeons that provided a plan to engage the state legislature on a high-priority issue.
