Each expanded their capacity to offer revenue-producing classes and performance programs, and therefore experienced growth and increased revenue. The Studios also offered its public performance space to external performing arts groups at reduced rates, allowing those groups to reach increased audiences and produce a more consistently high-quality product. We also launched our partnership with Sac City Unified School District, and, with our resident arts organizations, served 700 students from Title I schools at SCUSD with in-school residencies, access to free student tickets for professional programs, and free summer programs.
