SCHOLARSHIPS - Scholarships are essential to ensuring the educational attainment of Zane State College students. Many of the students here at the College come from generational poverty and, consequently, are first generation college students. The adult learners we serve are raising families while working several jobs, in addition to attending classes. Without the financial support these scholarships provide, many of our students would not be able to reach their educational goals. Each year, the Foundation helps approximately 150 deserving students. These funds transform the lives of our students and their families as they enter the local workforce with newly developed skills. The great majority of Zane State College graduates stay in the local area; therefore, the impact of these scholarships truly become an investment in the economic vitality of our communities.

DISTANCE LEARNING TECHNOLOGY - In accordance with the specified wishes of donors, the foundations made improvements to technology in two campus rooms that are used for distance learning.
