Freedom Center believes their estimates are appropriate based on the current facts and circumstances. Revenues derived from certain catering services provided by the Freedom Center, certain museum shop sales and advertising income that are not substantially related to furthering the Freedom Center's mission are considered unrelated business income. Taxes on unrelated business income are paid in accordance with the Internal Revenue Code. No accrual has been provided because the amount of tax due is immaterial.
