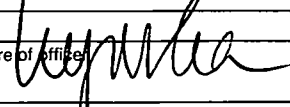

 CARTM's mission is to eliminate waste by inspiring our community to rethink, reduce, reuse and recycle. We provide facilities at the Manzanita Transfer Station to reduce waste by recycling and reuse, and through the creative reuse of materials otherwise destined for the landfill. We encourage citizens and visitors to take responsibility for the waste they generate.

 The Refindery Re-use store. Usable items donated by the public and/or diverted from trash are sold to support our recycling and community outreach programs. Items sold include household goods, small appliances, electronics, furniture, building materials, tools and fixtures. Customers include medium and low income individuals, artists, bargain hunters and 'do it yourself' craftsmen and seasonal visitors.

We encourage reuse as the preferred method of disposal through creative displays, events and promotions. We rent durable dinnerware, linens and utensils to the public to discourage the use of disposables at community events.

We have a local pick-up and delivery service for donated and purchased reusable items.

4b (Code:) (Expenses \$ 129,972 including grants of \$) (Revenue \$ 125,972)
 Recycling depot. Households and businesses drop off paper, plastics, metals, glass, tires, paint, yard debris and other recyclable materials, which are separated into 40+ categories to maximize value when marketing to brokers and other recycled-material buyers.

In calendar year 2016, CARTM processed 1,340 tons of recyclable materials, which represents 55% of the solid waste passing through our facility.

We encourage recycling by intercepting and diverting recyclable materials from trash, and through ongoing engagement with the public.

4c (Code:) (Expenses \$ 105,570 including grants of \$) (Revenue \$ 112,571)
 Transfer Station. CARTM manages the North Tillamook County transfer station under a franchise agreement. Households and small businesses deliver solid waste (trash). Customers are actively encouraged to separate recyclable and reusable items from trash at no charge, saving them money on disposal fees, and reducing the amount sent to the landfill. CARTM also diverts materials from paid trash loads.

CARTM is paid a fee by Tillamook County to operate the trash station, as well as incentive fees for collecting certain recyclable materials on behalf of the County. We offer expanded waste processing services to home builders and remodeling contractors, who generate significantly more waste than households.
