The President will present the requests to SMF's Grants Committee for review and evaluation. All requests have the approval and endorsement of the department's Executive Director, the Chief Operating Officer (COO), and the Chief Financial Officer (CFO) of SMMC. The approval and endorsement of grant requests are the responsibility of the requestor. The President of SMF is responsible for monitoring, receiving, processing, and reporting all grant requests. The Grants Committee meets twice a year in the months of April and October. All requests for capital and program service expenditures are submitted by the Administration of SMMC for review no later than April 1st prior to the fiscal year in which monies are to be expended. SMF's President meets with the COO and CFO of SMMC in order to determine which capital items (property, plant, building, equipment, or projects) and program services are most needed by SMMC. SMF's Grants Committee considers each grant separately and determines which of those requests provides assistance most needed by SMMC. The Grants Committee may seek the assistance of SMMC's CEO, COO, and/or CFO in prioritizing those needs. The total grant requests approved during any fiscal year shall not be a total amount that would jeopardize the financial and operational viability of SMF in order to further its mission and purpose. SMMC provides feedback/monitoring of the use of the grants to SMF, which is then reported back to the SMF Board of Directors. A portion of the grants given to SMMC are used for the scholarship program. SMMC offers scholarships to all eligible staff (clinical and non-clinical) of the affiliated medical center on an annual basis. Recipients are chosen by the Scholarship Committee annually from a pool of applicants. There are various requirements and criteria that must be met in order to be awarded a scholarship from the organization. The purpose of the scholarship program is to assist in the education of current staff to enhance the medical and administrative function of the affiliated medical center's treatment and services provided to the community. The process involves potential recipients receiving endorsements from senior staff in addition to personal narratives from each, and an explanation of financial need. The packets, and all required information and documentation is distributed to the Scholarship Committee for scoring and ranking, and ultimate selection of awardees. The requirements include the following: 1) Must be an eligible employee, 2) Must attend, or be attending, an accredited institution, 3) The area of study must be related to career goals at the affiliated medical center (clinical or non-clinical), and 4) The educational performance and adherence to aforementioned criteria of the recipient is monitored throughout the award year.
