Voting members shall have the right to vote on the disposition of all or substantially all of the organization's assets, any merger and its principle terms, and any amendment of those terms, any election to dissolve the corporation, the amendment of the corporation's Articles of Incorporation or bylaws, and such other matters as set forth in LAAC's bylaws or otherwise required by state law.
