ACE PROVIDED STUDENTS WITH COMMUNITY EMPOWERMENT SCHOLARSHIPS AND FUNDING TO EXPAND PROGRAMMING INTO 10 NEW SITES, CONDUCT RESEARCH AND SUPPORT EXPANSION. ALONG WITH SPORTSBACKERS ACTIVE RVA, GIRLTREK, AND 3 WINS, ACE AWARDED COMMUNITY EMPOWERMENT SCHOLARSHIPS TO FITLOT, A 501 (C)3, NON-PROFIT CORPORATION COMMITTED TO HELPING COMMUNITIES FIND THE RESOURCES THEY NEED TO PLAN, BUILD AND PROGRAM OUTDOOR FITNESS PARKS BECAUSE THEY BELIEVE EVERY INDIVIDUAL CAN AND SHOULD ENJOY THE HEALTH BENEFITS OF A MORE ACTIVE LIFESTYLE. ACE PARTNERED WITH THE NATIONAL SENIOR GAMES ASSOCIATION (NSGA) TO HELP SUPPORT PHYSICAL ACTIVITY EFFORTS FOR AMERICANS OVER 50 YEARS OF AGE IN ATTEMPT TO HELP THEM LEAD HEALTHY AND ACTIVE LIVES THROUGH MOVEMENT. NSGA IS A 501 (C)3, NONPROFIT CORPORATION DEDICATED TO PROMOTING HEALTH AND ACTIVE LIFESTYLES FOR ATHLETES AGE 60 AND OVER, AND IS A RECOGNIZED MULTI-SPORT ORGANIZATION OF THE UNITED STATES OLYMPIC COMMITTEE. ACE SUPPORTED THE NATIONAL SENIOR GAMES EVENT THROUGH SPONSORSHIP EFFORTS AND CREATION OF PHYSICAL ACTIVITY CONTENT AND A WELLNESS PORTAL TO DEMONSTRATE THE NEED FOR CLINIC-TO-COMMUNITY LINKAGES TO BETTER THE HEALTH OF AMERICAN, ACE FUNDED AND SUPPORTED INITIATIVES SUPPORTING NEW SYSTEM APPROACHES. THIS INCLUDED RESEARCH FUNDING AND HEALTH COACH SCHOLARSHIPS AND FACE-TO-FACE EDUCATION, INSTRUCTION FOR A CLINIC-TO-COMMUNITY PILOT USING THE LOCAL SAN DIEGO 2-1-1 FOR BEHAVIOR CHANGE SERVICES TO OVERWEIGHT AND OBESE CHILDREN. ADVOCACY ENGAGING WITH AND SERVING AS A RESOURCE FOR POLICYMAKERS AT MUNICIPAL, STATE AND FEDERAL LEVELS HAS HELPED ACE CONVEY THE IMPORTANCE OF STRUCTURED, SUPERVISED PHYSICAL ACTIVITY AND EXPANSION OF THE HEALTHCARE CONTINUUM TO INCLUDE HIGHLY QUALIFIED HEALTH COACHES AND FITNESS PROFESSIONALS. IN 2017, ACE CONTINUED TO GROW THEIR ADVOCACY PRESENCE BOTH WITHIN THE FITNESS INDUSTRY AS WELL AS WITH THOSE ADJACENT TO THE INDUSTRY, SUCH AS CONSUMERS, LIKE-MINDED ORGANIZATIONS, ETC., UTILIZING BOTH FACE-TO-FACE AND ONLINE PUBLIC EFFORTS.
