The written notices of disclosures shall be filed with the CEO or such other person designated by the CEO to receive such notifications. At the meeting of the Executive Committee, all disclosures of real or apparent conflict or duality of interest shall be noted for the record in the minutes. An individual trustee, officer, agent, or employee who believes that he or she, or an immediate member of his or her immediate family, might have a real or apparent conflict of interest, in addition to filing a notice of disclosure, must abstain from participating in discussions or deliberations with respect to the subject of the conflict (other than to present factual information or to answer questions),² using his or her personal influence to affect deliberations,³ making motions,⁴ voting,⁵ executing agreements, or⁶ taking similar actions on behalf of the organizations where the conflict or duality of interest might pertain by law, agreement, or otherwise. At the discretion of the Executive Committee, or a committee thereof, a person with a real or apparent conflict or duality of interest may be excused from all or any portion of discussion or deliberations with respect to the subject of the conflict. A member of the Executive Committee, or a committee thereof, who, having disclosed a conflict or duality of interest, nevertheless shall be counted in determining the existence of a quorum at any meeting in which the subject of the conflict is discussed. The minutes of the meeting shall reflect the individual's disclosure, the vote thereon, and the individual's abstention from participation and voting. The Executive Director shall ensure that all trustees, officers, agents, employees, and independent contractors of the organization are made aware of the organization's policy with respect to conflicts or duality of interest.
