The Toledo Symphony's 2016-17 season, its 73rd, was one of the most memorable and successful in memory. From the opening night gala with Kristin Chenoweth to the season-ending orchestra recital with Rene Fleming, the Toledo Symphony proved that it could reach for the stars and bring them back to Toledo. During this season, the orchestra sold out nine performances and achieved its best cumulative attendance in three years. Ticket revenue increased 11% from the previous season. The 2016-17 season broke new ground with innovative community partnerships like Bach Around the Clock (with the Toledo Museum of Art), the Hot Glass Cool Music Festival (with the Arts Commission of Greater Toledo), and the Mideast x Midwest celebration (with the National Arab Orchestra). We also saw strong growth in our educational operations, with record enrollment in our three youth orchestras and the Toledo Symphony School of Music. The orchestra also enjoyed successful educational programming, including sold-out Young People's Concerts and the popular Toledo Public Schools 4th Grade concert. The 2016-17 season represented an era of change, as Zak Vassar began his first year as President & CEO and Stefan Sanderling stepped down after 15 seasons as Principal Conductor. The staff also saw several major appointments, including Vice President for Development, Marketing Director, and Education Director. The future of the Toledo Symphony is bright, thanks to strategic vision, strong artistic programming, deep community collaboration, and an expanding donor base.
