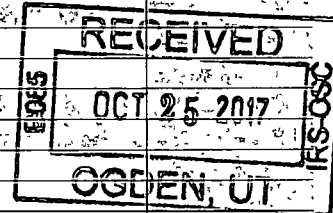

AMENDMENT TO TRUST AGREEMENT OF ELDER FOUNDATION

This Amendment to Trust Agreement of Elder Foundation is made this Fourth day of November, 2016 by Alan H Elder, Amy B Elder, Jack E Elder, Julie A Elder, Louise H B S Elder, and Paul A Elder, Trustees although signatures may be affixed on different dates

WITNESSETH

WHEREAS, Elder Foundation (the "Trust") was founded pursuant to a Trust Agreement dated November 22, 1994 (the "Agreement") and

WHEREAS, certain concerns regarding membership rules have arisen which the Trustees and Members believe the existing Agreement does not adequately address


NOW, THEREFORE, in consideration of the terms, covenants and conditions herein set forth, the parties agree with each other to amend the Agreement as follows

- 1 Members in the Trust shall lose membership in the event of death, disability, divorce or convicted felony. Lost membership may be restored upon application accepted by a super-majority vote of Trustees (at least 60% of the total number of Trustees) at a duly called Executive Session meeting of Trustees as called by the Chair
- 2 Trustees in the Trust shall lose trusteeship in the event of death, disability, divorce or convicted felony. Lost trusteeship may be restored upon application accepted by a super-majority vote of Trustees (at least 60% of the total number of Trustees) at a duly called Executive Session meeting of Trustees as called by the Chair
- 3 A new spouse as a result of a second marriage of an existing member must apply for membership which membership acceptance requires a super-majority vote of Trustees (at least 60% of the total number of Trustees) at a duly called Executive Session meeting of Trustees as called by the Chair


In all other respects, the provisions of the Trust Agreement dated November 22, 1994 remain in full force and effect
