IN APRIL 2017, THE SCHOOL HIRED A NEW DIRECTOR OF DEVELOPMENT WITH SIGNIFICANT NOT-FOR-PROFIT EXPERIENCE IN ORDER TO INCREASE THE AMOUNT OF REVENUE FROM FUNDRAISING, INCLUDING ANNUAL FUNDRAISING AND MAJOR GIFTS. IN AUGUST 2017, THE SCHOOL HIRED A NEW DIRECTOR OF FINANCE & OPERATIONS WHO HAS IMPROVED THE EFFICIENCY OF FINANCIAL OPERATIONS AND REPORTING, AND IMPLEMENTED BEST PRACTICES ON FINANCIAL CONTROLS YIELDING A FURTHER REDUCTION IN EXPENSES. THE SCHOOL HAS FURTHER INCREASED REVENUES FROM RENTAL OF ITS FACILITIES DURING SUMMER BREAK AND NON-SCHOOL HOURS DURING THE SCHOOL YEAR.
