Westcott Hunter, Inc. obtained external valid comparable market data from published sources for comparable positions, and established a Form 990 peer group of comparable organizations. The third step consisted of reviewing the disqualified individuals and market data, considering management's recommendations for salary increases and incentive awards, then finalizing and approving salary increase and incentive awards for all "disqualified persons". For fiscal year 6/30/16 the Compensation Committee compared the compensation for "Disqualified Persons" to that of the established "Peer Group". Noting that the compensation for the Disqualified Persons was reasonable.
