Where a conflict is disclosed, the facts are presented to our governing board for discussion and a determination of the action (if any) to be taken.

An independent review is conducted as needed to ensure our Chief Executive Officer's total compensation package remains competitive/comparable to that of CEO's leading similar organizations, with similar budgets, supporting similar consumers, and confronting similar fiscal and operational challenges.
