OUR FOOD PANTRIES OPERATE OUT OF SIOUX FALLS AND RAPID CITY AND SERVE APPROXIMATELY 40,000 FAMILIES EACH YEAR. OUR BACKPACK PROGRAM PROVIDES AT-RISK CHILDREN WITH NUTRITIOUS, EASY-TO-PREPARE FOOD DURING WEEKENDS AND HOLIDAYS WHEN SCHOOL IS NOT IN SESSION. THROUGH THIS PROGRAM MORE THAN 5,200 CHILDREN ARE SERVED STATEWIDE EACH WEEK DURING THE SCHOOL YEAR. OUR MOBILE FOOD PANTRY DISTRIBUTES FOOD IN VARIOUS RURAL COMMUNITIES ACROSS CENTRAL SOUTH DAKOTA. WITH THE HELP OF NUMEROUS COMMUNITY VOLUNTEERS, THE MOBILE FOOD PANTRY DISTRIBUTES OVER 600,000 POUNDS OF FOOD ANNUALLY. WE PILOTED OUR FIRST SCHOOL FOOD PANTRY IN FISCAL YEAR 2016.
