Enlace organizes community-based workshops, provides free legal services and engages in policy advocacy through a partnership with the Community Activism Law Alliance. Enlace's free legal clinic provides a wide range of services in the areas of immigration, family, education, labor, criminal records, housing and consumer issues. Attorneys and staff support community members with immigration application processes, and they provide educational sessions related to topics such as "know your rights and current immigration policy." Community leaders work with staff to develop and implement Enlace's advocacy platform. Enlace convenes a semi-annual leadership academy concentrating on the fundamentals of power and community organizing. Hundreds of Enlace member connect with broader coalition partnerships and participate in advocacy efforts at the local, city, county, state, and federal levels.
