Providence-Providence Park Hospital offers various free clinics. For many Michigan residents, finding someone to care for them when they are sick is not as easy as making an appointment. Lack of health insurance, transportation issues and language barriers combine to create challenges. During the fiscal year ending June 30, 2017, Providence-Providence Park Hospital treated adults and children from the community for a total of 148,570 patient days of service.
