THE FIA ART SCHOOL RUNS AT FULL CAPACITY FROM 9 AM TO 9 PM WITH AN ANNUAL ENROLLMENT OF MORE THAN 1,700 STUDENTS. THE ART SCHOOL REMAINS DEDICATED TO THE EDUCATIONAL ENLIGHTENMENT OF THE PUBLIC THROUGH FORMAL INSTRUCTION IN DRAWING, PAINTING, PHOTOGRAPHY, MIXED MEDIA, PRINTMAKING, CERAMICS, GLASS MOSAIC, FIBER, AND METAL SCULPTURE. THE SCHOOL ALSO PROVIDES SUMMER CAMPS FOR YOUTH, FREE FAMILY ACTIVITIES, AND A PRE-COLLEGE PORTFOLIO DEVELOPMENT PROGRAM FOR GIFTED HIGH SCHOOL STUDENTS. THE FIA'S BEAUTIFUL, STATE-OF-THE-ART FACILITY CONTINUES TO BE A TOP VENUE IN GENESEE COUNTY FOR HOSTING A VARIETY OF EVENTS THROUGHOUT THE YEAR. THE FACILITY RENTAL PROGRAM GENERATES MORE THAN 60,000 ANNUALLY IN EARNED INCOME FOR THE FIA THROUGH THE RENTAL OF PUBLIC SPACES SUCH AS THE LOBBY, ISABEL HALL, THEATER, BOARD ROOM, LECTURE ROOM, AND COURTYARD (WEATHER PERMITTING). THE GALLERIES ARE ALSO FREQUENTLY OPEN DURING EVENTS AND RENTALS AND RENTALS BRING IN MORE THAN 6,000 VISITORS EACH YEAR. IT IS AN ESPECIALLY UNIQUE EXPERIENCE FOR WEDDING RECEPTIONS, ANNIVERSARIES, BABY SHOWERS, ENGAGEMENT PARTIES, MUSICAL CONCERT, FASHION SHOWS, COLLEGE EVENTS, HOLIDAY LUNCHEONS, FILMS SCREENINGS, PRIVATE DINNERS, CLIENT RECEPTIONS, WORKSHOPS AND SYMPOSIA. THE FIA IS ALSO BECOMING A UNIQUE LOCATION FOR MARRIAGE PROPOSALS AND HIGH SCHOOL SENIOR AND WEDDING PHOTOS. THE FIA'S FOUR ANNUAL FUNDRAISERS: THE COMMUNITY GALA, WINE TASTING, THE PARTY, AND BEER TASTING, ALONG WITH THE SUMMER AND WINTER ART FAIRS (HOSTED BY FIA AUXILIARY GROUPS) ATTRACT MORE THAN 10,000 VISITORS AND GENERATE NEARLY 200,000 INCOME ANNUALLY. THE FIA IS A NON-PROFIT MEMBERSHIP ORGANIZATION WITH MORE THAN 3,400 MEMBERS. THE FIA OFFERS A VARIETY OF MEMBERSHIP LEVELS FOR AGES 25 THROUGH ADULT THAT INCLUDE BASIC BENEFITS SUCH AS FREE ADMISSION AND DISCOUNTS ON FIA ART SCHOOL CLASSES TO HIGHER-LEVEL BENEFITS SUCH AS RECIPROCAL MEMBERSHIP PRIVILEGES TO OVER 750 MUSEUMS NATIONWIDE. THE FIA ALSO OFFERS SEVERAL SPECIAL MEMBERSHIP INITIATIVES INCLUDING THE FLINT PRINT CLUB, DEDICATED TO PRINTMAKING AND THE PURSUIT OF PERSONAL COLLECTING, THE FILM SOCIETY FOR ENTHUSIASTIC FILMGOERS OF THE WEEKLY FILM PROGRAM, THE COLLEGE TOWN PROGRAM WHICH PROVIDES FREE MEMBERSHIPS TO STUDENTS IN GOOD STANDING FROM ANY U.S. COLLEGE OR UNIVERSITY, AND THE BLUE STAR MUSEUM PROGRAM OFFERING FREE ADMISSION TO ACTIVE DUTY MILITARY AND THEIR FAMILIES FROM MEM
