The Michigan Chamber PAC II is used to pay for ballot question activities, ballot question litigation expenses, polling, and voter education. The Michigan Chamber of Commerce from its general treasury makes issue advocacy advertising expenditures. None of these ads expressly advocate the election or defeat of candidates. The Michigan Chamber of Commerce files an 1120-POL and pays a tax on its net investment income.
