The Foundation exists to raise, receive and administer donations for Delta College, a related organization, by building relationships with donors and directing fundraising efforts. All contributions to the Foundation are transferred or spent to benefit the College's students, educational programs, staff development, capital projects or other critical financial needs.

Contributions of cash, equipment and classroom supplies donated to the Foundation for instructional purposes were transferred to the College to enhance educational programs and to provide scholarships and awards. The Foundation also used funds to publish and distribute an informative magazine highlighting Delta College success stories, programs and events available to residents in the surrounding communities. These contributions benefitted the entire college community of 15,100 students and staff, as well as residents of the Great Lakes Bay Region, by providing valuable information of opportunities available to them.

4b (Code:) (Expenses \$ 491,263 including grants of \$ 491,263) (Revenue \$)
Contributions for the College's Endowment Fund were transferred to the College for investment. Investment income generated by the Endowment Fund provided over 300 scholarships and awards during the year. It also supported numerous programs and projects such as the President's Scholar Program, the Possible Dream Program, Science, Technology, Engineering & Math (STEM) Education and several Teaching Chairs. These programs benefitted the entire Delta College community of 15,100 students, faculty and staff, as well as residents of all ages living in the surrounding communities.

4c (Code:) (Expenses \$ 8,807 including grants of \$ 8,807) (Revenue \$)
Donations for non-academic assistance were used to provide emergency funding to currently enrolled students to help them complete the classes they were attending. Students received financial assistance for rent, utilities, transportation and groceries. This additional support benefitted approximately 160 students.
