Payout of any performance bonus is subject to overall consolidated organizational financial performance to ensure sufficient funds and is not paid until the financial results of the foundation's supported organization, the Detroit Regional Chamber, are determined at the end of the fiscal year. The bonuses are paid out within 75 days of the end of the fiscal year. For the year ended June 30, 2017, the CEO bonus was approved by the compensation committee chair to be paid out in July 2017. If the board approved budgeted net performance results of the consolidated chamber were not met, the bonus amounts would be reduced or eliminated so as not to create negative net earnings as compared to the budget for the foundation. Bonus pools for the CEO, executive management team, and other employees are approved by the compensation committee.
