If a covered individual discovers a potential conflict of interest previously unknown or if new situations develop that result in a potential conflict of interest, the covered individual shall immediately disclose the potential conflict of interest to the Foundation President. An individual covered under this policy who is unable to participate in a vote due to a conflict of interest shall count only for the purpose of determining the presence of a quorum. It is the intent of this policy that covered individuals shall err on the side of disclosure to the extent there is a potential conflict of interest or the perception of a conflict.
