Wisconsin Public Radio (WPR) is a civic and cultural resource which exists to enlighten and enrich the quality of life for the people within its listening area. WPR's mission is to serve the entire state by producing, acquiring, and delivering high quality radio programming that serves the public's need to discuss ideas and opinions and that provides cultural enrichment, intellectual stimulation, and intelligent, enlightening entertainment throughout the WPR network. WPR's most recent annual report indicates nearly 500,000 listeners per week, and over 54,000 contributors. WPR broadcasts from 34 radio stations throughout the state and streams live online providing programs for its three networks: the Ideas Network, the NPR News and Classical Music Network, and the 24-hour HD Classical Music Network.

The Wisconsin Public Television (WPT) mission is to boldly enrich, educate and entertain diverse audiences of children and adults through innovative use of television production and broadcasting, other communications technologies and community engagement. WPT provides access to local on-air and national content, extending its reach and impact in the communities served through the WPT network. WPT can be viewed throughout Wisconsin on its main channel, the Wisconsin channel, WPT Create, and on 24 hour PBS kids channel. WPT broadcasts to over 500,000 viewers each week. During FY 17, WPT had approximately 63,000 contributors.
