Concerts The Organization presented its 135th anniversary season, featuring world-renowned classical music artists and ensembles in various concert series from September through June, as well as professional local musicians for approximately 17,000 Minnesota audience members. Included in the performances and events were the International Artist Series (IAS), presented at the Ordway Center for the Performing Arts, serving more than 7,000 audience members. The Organization presented three evening performances in Landmark Center called "Live at the Museum" and free weekly noontime Courtroom Concerts at Landmark Center featuring primarily Minnesota-based performers and composers for 3,500 people.

Museum Open six days a week throughout the year, the Schubert Club Museum includes an extensive collection of rare and historic keyboards and other musical instruments, and more than 100 original composer letters in the Gilman Ordway Manuscript Collection. Designed to accommodate small to medium size school group tours, the museum galleries are located on the second floor of Landmark Center. Admission is free and there were over 8,000 visitors last year. An experiential gallery features an Indonesian Gamelan orchestra and a set of early 20th century recorded music players. One gallery is dedicated for hands-on experiences with 4 keyboard instruments from multiple centuries. A temporary exhibit called Brass from the Past will remain in the Museum for about a year. Performances and lectures, often featuring museum exhibits, are held in a dedicated performance gallery and promoted with the title "Live at the Museum"
