The program provides arts enrichment while inspiring multicultural outreach, awareness, and appreciation. In each two-year cycle, we serve approximately 90,000 students and 15,000 adults through approximately 45 performances and 300 educational activities. Caravanserai: A Place Where Cultures Meet creates new pathways for Americans to experience the diversity of contemporary Muslim artistic expressions by introducing U.S. audiences to exciting and dynamic Muslim performing artists. The 2015-2016 Caravanserai American Voices season featured contemporary Muslim American musical expressions shared by Palestinian-American multi-instrumentalist Ronnie Malley, Indian-American soul-singer Zeshan Bagewadi, popular hip-hop/soul duo The Reminders, hip-hop dance troupe MaMa2 and DJ Man-O-Wax. In September 2016, Caravanserai concluded its programming with a professional development session, marketplace booth and independent showcase featuring these artists at the 2016 Arts Midwest Conference in Milwaukee, WI. The grant period of support for the program ended on September 30, 2016 and the final program report was submitted to its primary funder, Doris Duke Foundation for Islamic Art, in November 2016. The 29th Annual Conference was held in Milwaukee, Wisconsin, September 13-16, 2016, it served 1,075 performing artists, managers, and agents, performing arts presenters/venues, and arts administrators from 46 states and the District of Columbia, six Canadian provinces, and the countries of Chile, China, Brazil, and France. Each year the four-day Arts Midwest Conference provides opportunities to network, learn, and experience live performing arts. Arts Midwest continues to manage Shakespeare in American Communities, which supports theater companies bringing professional productions of Shakespeare to high school and middle school students across the country. In 2017-2018, this national program of the National Endowment for the Arts awarded \$1 million in grants to 40 nonprofit, professional theater companies across the nation to perform the works of William Shakespeare for students. Each of the participating theater companies will present productions of Shakespeare plays to students from 10 or more schools. Accompanying educational activities include in-school residencies, workshops, and post-performance discussions. Through support from the National Endowment for the Arts, the NEA Performing Arts Discovery builds and sustains international arts networks and highlights the rich diversity of the U.S. performing arts market. The program seeks to share exceptional performers who may be unfamiliar to foreign presenters, provide a forum for collaboration between cultural organizations, and ultimately expand the global opportunities for performing artists from across the United States. In pursuit of this goal, the NEA Performing Arts Discovery brings booking representatives and leaders from global performing arts venues to the annual Arts Midwest Conference. International delegates receive a special orientation before participating fully in Conference programming, including visiting the exhibit hall, joining networking events, and attending performance showcases. After the Conference, Arts Midwest also arranges an in-depth forum on a local community with presentations by local experts, meetings with cultural leaders, studio and venue visits, and performances by local ensembles. In 2016, the NEA Performing Arts Discovery hosted two delegates from Brazil, five delegates from Chile, five delegates from China. Arts Midwest Folkfest presents traditional music ensembles from Norway, Sweden, Finland, Denmark, and Iceland for intensive, week-long residencies that feature public performances and educational activities for all ages and levels of musical experience. The program visits small and mid-sized communities in six Midwestern states—North Dakota, South Dakota, Iowa, Minnesota, Wisconsin, and the Upper Peninsula of Michigan, all of which experienced a significant influx of Scandinavian immigrants during the 1800s and 1900s. The program seeks to deepen awareness of the Nordic traditions.
