Tuition assistance to individuals, True Light Christian School students, is based on a 3rd party analysis of each family's financial need. The family sends an application for assistance to the independent company who makes an analysis of their date and submits to the school the amount, if any, of financial need the family has for tuition. Only enrolled students are granted assistance in the form of a credit on their family's tuition account with the school.

Part IV Supplemental Information

Mission donations are given to domestic, Christian organizations as approved by the school board.

Part III (1)

Tuition assistance is based on financial need of a family. Assistance is limited to 50 % of invoiced tuition for grades kindergarten through 8th grade. Children of teachers can receive up to 100% of assistance, based on financial need. Each family must submit an application to the independent company that provides the analysis. To apply, each family must pay the registration fee to the school and the application fee to the company. In 2016/2017, tuition assistance was granted to 17 families for a total of 34 students.

Part III (2)

During specific chapels, such as Christmas and Missions Week, offerings are given to True Light for the benefit of specific, domestic ministries. In addition, the 7th & 8th grade students perform a dinner theatre to raise funds for missions. Approximately 1/2 of the mission funds raised were used for a mission trip taken by the 7th/8th grade classes to Minneapolis/St. Paul in May. The remaining funds are paid out to Christian ministries.
