RESEARCH PROGRAM CHILDREN'S CANCER RESEARCH FUND PROVIDES FUNDING TO ACCELERATE CANCER RESEARCH THAT LEADS TO BETTER TREATMENTS AND OUTCOMES FOR CHILDREN DIAGNOSED WITH CANCER. JUST AS PAST RESEARCH SUPPORT IS CURING CHILDREN TODAY, THE INVESTMENTS WE MAKE NOW ARE HELPING PHYSICIANS AND RESEARCHERS MAKE MORE IMPORTANT DISCOVERIES HERE ARE JUST A FEW OF THE HIGHLIGHTS FROM THE PAST YEAR OF RESEARCH. OSTEOSARCOMA: THIS BONE CANCER IS INFAMOUS FOR BEING DIFFICULT TO TREAT BECAUSE THE GENES THAT PROMOTE THIS CANCER'S DEVELOPMENT ARE LARGELY UNKNOWN, MAKING IT HARDER FOR DOCTORS TO COMBAT. RESEARCHERS FUNDED BY CCRF'S ZACH SOBIECH OSTEOSARCOMA FUND GENERATED AND ANALYZED 119 OSTEOSARCOMA TUMORS IN MICE AND IDENTIFIED 233 GENES THAT ARE PREVALENTLY ALTERED IN OSTEOSARCOMA, AND THEY FOUND THREE BIG GENETIC DRIVERS OF OSTEOSARCOMA CALLED CSF1R, SEMA4D AND ZNF217. NOW THAT RESEARCHERS KNOW THESE GENES ARE DRIVERS OF OSTEOSARCOMA, THEY CAN FIND TARGETED TREATMENTS AND THERAPIES TO DEFEAT THE DISEASE, AND HOPEFULLY, GIVE KIDS BETTER OUTCOMES. THEY'RE STARTING WITH SEMA4D, A GENE THAT'S ALSO EXPRESSED IN OTHER CANCERS LIKE BREAST CANCER -- USING A DRUG THAT ALREADY EXISTS TO HELP DEFEAT IT. THE RESEARCH DONE AT THE UNIVERSITY OF MINNESOTA SHOWED THAT THE DRUG HAS THE POTENTIAL TO BE EFFECTIVE IN KIDS AND TEENS WITH OSTEOSARCOMA. THE OSTEOSARCOMA TEAM WILL PARTNER WITH CHILDREN'S ONCOLOGY GROUP TO START THE PHASE I TRIAL. FOR FAMILIES FACING CANCER, THIS BREAKTHROUGH COULD BECOME ANOTHER TREATMENT OPTION FOR KIDS. THE ZACH SOBIECH OSTEOSARCOMA FUND DONORS HELPED RESEARCHERS SECURE AN ADDITIONAL \$4 MILLION IN FUNDING FROM GOVERNMENT GRANTS AND OTHER SOURCES. DONOR SUPPORT HAS ALSO HELPED RESEARCHERS PUBLISH 15 NEW, DISCOVERIES, SPREADING OSTEOSARCOMA KNOWLEDGE AROUND THE GLOBE. BRAIN TUMORS: MICHAEL OLIN, PHD AND CHRIS MOERTEL, MD, RESEARCHERS AT THE UNIVERSITY OF MINNESOTA, HAVE DISCOVERED THAT A SPECIFIC PROTEIN CALLED CD200 INTERFERES WITH A POTENTIALLY LIFESAVING BRAIN TUMOR VACCINE. THE UNIVERSITY OF MINNESOTA HAD DEVELOPED A BRAIN TUMOR VACCINE THAT DEMONSTRATED PROMISING RESULTS WITH MINIMAL TOXICITY FOR BRAIN CANCER PATIENTS, BUT AS THEY TESTED THE VACCINE, THEY DISCOVERED THAT BRAIN TUMORS SURROUND THEMSELVES WITH A SHIELD THAT PREVENTS THE IMMUNE SYSTEM FROM ATTACKING THE TUMOR. MOERTEL AND OLIN HYPOTHESIZED THAT THIS SHIELD WAS CREATED IN PART BY CD200, WHICH CLUSTERS AROUND BLOOD VESSELS THAT SURROUND TUMORS. CD200 STOPS THE T-CELLS, THE CELLS THAT SHOULD ATTACK THE TUMORS. T-CELLS MOVE THROUGHOUT THE BODY VIA BLOOD VESSELS, AND WHEN THE T-CELLS MEET CD200 SURROUNDING THE TUMORS THEY ARE SUPPOSED TO ATTACK, THEY ARE SHUT DOWN. OLIN FOUND A WAY TO TURN OFF THE PROTEIN USING WHAT HE CALLS A CD200 INHIBITOR. THIS INHIBITOR STOPS THE PROTEIN FROM SHUTTING OFF THE T-CELLS, LETTING THE T-CELLS RECOGNIZE THE TUMOR CELLS AND FIGHT THEM. ONCE HE DISCOVERED HOW TO TURN CD200 OFF, HE SHARED HIS FINDINGS WITH THE UNIVERSITY OF MINNESOTA COLLEGE OF VETERINARY MEDICINE AND ELIZABETH PLUJAR, DVM, PHD. THEY COLLABORATED TO TREAT COMPANION DOGS WITH HIGH-GRADE BRAIN TUMORS USING THE BRAIN TUMOR VACCINE AND OLIN'S NEW CD200 INHIBITORS. AFTER TREATMENT, MRIS SHOWED THAT MANY OF THE DOGS' TUMORS HAD DISAPPEARED. TODAY, THE DOGS HAVE REMAINED TUMOR-FREE AS FAR AS 530 DAYS FROM TREATMENT. BECAUSE DOG AND HUMAN BRAIN TUMORS ARE VERY SIMILAR, RESEARCHERS ARE CONFIDENT THAT THE NEW CD200 INHIBITOR/VACCINE COMBINATION WILL BE JUST AS EFFECTIVE IN HUMANS. OLIN AND MOERTEL ARE HOPING TO BRING THE BREAKTHROUGH DISCOVERIES TO A HUMAN CLINICAL TRIAL IN THE NEXT YEAR. LEUKEMIA: CERTAIN TYPES OF LEUKEMIA TREATMENTS INCLUDE STEM CELL TRANSPLANTS. A STEM CELL TRANSPLANT REPLACES IMMATURE BLOOD-FORMING CELLS IN THE BONE MARROW THAT HAVE BEEN DESTROYED BY DRUGS, RADIATION OR DISEASE. THEY ARE INJECTED INTO THE PATIENT AND MAKE HEALTHY BLOOD CELLS. HOWEVER, AFTER STEM CELL TRANSPLANT, CHILDREN'S IMMUNE SYSTEMS ARE KNOCKED DOWN, INCREASING THEIR RISK OF SERIOUS COMPLICATIONS AND EVEN DEATH DUE TO SIMPLE CONDITIONS LIKE THE COMMON COLD. CCRF SUPPORTED THE WORK OF RESEARCHERS WHO ARE USING CELLS CALLED THYMIC PROGENITORS TO IMPROVE CHILDREN'S IMMUNE FUNCTION AFTER TRANSPLANT. IN LABORATORY MODELS, THYMIC PROGENITORS HAVE HELPED REPAIR TISSUES DAMAGED BY CHEMOTHERAPY AND RADIATION AS WELL AS SERVE AS PRECURSOR CELLS TO FUTURE T CELLS THAT PROTECT PATIENTS FROM INFECTIONS. HOWEVER, SCIENTISTS ARE ONLY ABLE TO RETRIEVE A VERY SMALL NUMBER OF THYMIC PROGENITORS FROM UMBILICAL CORD BLOOD AND HAVE BEEN SEARCHING FOR WAYS TO GENERATE LARGER QUANTITIES. OVER THE PAST YEAR, RESEARCHERS HAVE DEMONSTRATED THAT THEY CAN PRODUCE VASTLY GREATER NUMBERS OF THYMIC PROGENITORS FROM STEM CELLS EXPANDED IN CULTURE USING SR-1. THEY'RE CURRENTLY DEVELOPING A HUMAN CLINICAL TRIAL TO DETERMINE THE MAXIMAL TOLERABLE DOSE OF THYMIC PROGENITOR CELLS.
