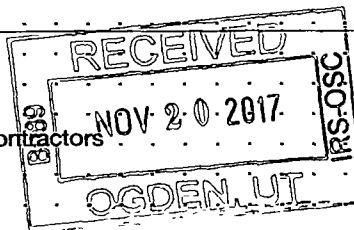

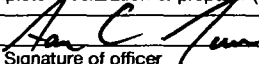

The Major Landers Scholarship Program is the responsibility of the IBA Endowment Fund Committee. Up to six scholarships are awarded annually to high school seniors who plan to be music education majors in Iowa colleges or universities. The scholarship is provided to IBA members (band directors) during the fall semester who then share that information with their high school band students who are seniors.

Interested students then prepare to participate, beginning at their district level. The Iowa Bandmasters Association, inc. (IBA) has six geographical district organizations which host several events for IBA members including the district level scholarship auditions. Auditions and a music theory test are held in each of the six IBA districts to determine a district winner. District winners come to the annual Conference in May for the final auditions and a music theory examination to determine the first place, second place, and up to four finalist scholarship winners at the state level. The first place winner also performs her/his solo at the IBA Conference Banquet. The monetary amounts are as follows: 1st Place - \$2,000, 2nd Place - \$1,500, up to four finalists - \$1,000 each. In FY2016 \$7,500 in total was paid out to the recipients.

In addition to the Major Landers Scholarship Program IBA makes annual grants to the Iowa Alliance for Arts Education (IAAE) (\$3,000), the IAAE Mentor Program (\$350), Friends of Iowa Public Television (\$300), and the Iowa Band Conductors Forum (\$500) to support their efforts to "promote, encourage, enhance, and improve interest in and quality of band music in Iowa," the state purpose of IBA.

990EZ, Part I, Line 16

The Iowa Bandmasters Association, Inc. (IBA) holds an annual conference in May which includes continuing education clinics, concerts by bands at all levels from Iowa and around the midwest, workshops covering a variety of topics for band directors, IBA business meetings, IBA committee meetings, displays and exhibits by educational institutions and vendors, and an awards banquet to honor outstanding members, retirees, keynote speakers, and to feature the 1st Place winner of the Major Landers Scholarship. The Conference is regularly attended by over 1,200 people including IBA members, guests, family members, and workshop/clinic presenters. Expenses for the Conference are included in Part I, Line 16 (\$73,649.53).

As part of the Conference IBA sponsors the All-Iowa 8th Grade Honor Band, made up of representatives selected from the six IBA districts. As part of this event IBA contributes toward the composition of an original work to be performed by the band. This is included in Part I, Line 16 (\$1,000).

Also included in Line 16 are expenses related to computer equipment, software upgrades, and upgrades to the IBA website (www.bandmasters.org) (\$184.72).
