The path to self-sufficiency can sometimes begin at the most basic level of need. MLM's Community Care Centers provide food, rent and utility assistance, legal documents, household hygiene items, and diapers. MLM food pantries average 50 clients per day, receiving food for themselves and their families. 5,980 households received food from our pantries throughout the year, including 384 older adult households which were provided with Senior Commodities each month. The Saturday Breakfast Ministry provided 13,025 meals to Kansas and Missouri individuals in midtown Kansas City, Missouri and northeast Kansas City, Kansas. 654 households received emergency rent or utility assistance, preventing them from the threat of homelessness. 1,079 IDs, driver's licenses, and birth certificates were provided to meet legal documentation requirements for job placements and other services. 352 children were provided with monthly diapers.

Form 990, Part III, Line 4b:

MLM operates two permanent housing locations to serve the needs of chronically homeless, disabled and mentally ill individuals. Permanent, supportive housing has been shown to be the most effective method for addressing long term homelessness, especially for this population. The first priority for these programs is to get individuals off the streets, however MLM also provides a number of individualized supports in the area of physical and mental health, socialization, alcohol and smoking cessation and healthy living which includes exercise, gardening, and nutrition. MLM was able to serve 42 individuals in 2017 through our two grants: Grace Homes and Project Care.

Form 990, Part III, Line 4c:

Rarely are families homeless due to a single circumstance, and the path back to economic sustainability is often gradual. The Family Empowerment Continuum provided year-long case management and long-term assistance to 112 households. Services including long-term assistance with housing needs, employment support, referrals for supportive services, financial literacy, household skills, and assistance with items such as clothing, bus passes and personal identification based on an assessment of their long-term housing situation, employment, income resources, expenses, debts, and credit rating. Case management is then designed to help clients stop living from crisis to crisis and instead start saving money, reduce their debt and build assets like a car, a home, or an education. To ensure permanent and lasting solutions are in place for our clients, MLM will continue to follow families for up to five years.

MLM's Christmas Store, one of the largest gift-giving programs in Kansas City, gives out gifts, Bibles, blankets and food to over 900 families with over 1,000 children. Volunteers help sort gifts, set up the Christmas Store, assist clients in selecting gifts, and help clients carry their gifts to their car. Throughout the year, volunteers across the Kansas City Metro area also donated items for the Christmas Store.

Learning to Earning is a client-focused employment services program that is a component of MLM's Family Empowerment Continuum focused on increasing the income and employability of participants through the development of financial literacy and job readiness skills. The program assists participants with employment readiness (resume assistance, basic computer skills, interview skills), job applications (online application assistance, job log tracking, follow-up calls to employers), support (food, bus passes, clothing, phone cards, food handler cards, tools) and financial literacy (individualized financial plan, developing a monthly budget, discerning wants vs needs). In 2017, 199 individuals attained employment with the assistance of the Learning to Earning program.

Seniors and persons with disabilities come to MLM in need of ramps or minor home repair necessary to alleviate safety and security concerns so they may continue living independently and with as much dignity as possible. Typical projects for MLM's Minor Home Repair Program include building wheelchair ramps, installing new door locks, repairing staircase steps, building handrails for staircases, installing grab bars in bathrooms, and installing smoke detectors, lights, and air conditioners. Throughout 2017, the Minor Home Repair Team of 13 individuals completed repairs on over 71 homes, including the installation of 16 wheel chair ramps.
