Name Changers Child Sponsorship Program: Our sponsorship program is designed to personally engage sponsors with children and youth whom we minister to on a continual basis. We currently have sponsorship available in Sierra Leone, South Asia, and the Dominican Republic. Through sponsorship, the kids in our care receive regular nutritious meals, the opportunity for education and tutoring, basic medical care, and most importantly each child continually hears the Gospel and has the opportunity to know Christ in a personal relationship. Our hope is that through tangible needs being addressed and met, the Gospel is all the more put on display for children and the communities we serve.

Mission Expeditions: We lead teams throughout the year to serve on mission in each of our ministry locations. We currently send short-term teams to Sierra Leone, South Asia, and the Dominican Republic. Our teams assist in the discipleship process with the children we serve, as well as provide opportunities for children who may not have a relationship with Christ to be introduced to Him.

Illumin8: Through Illumin8, our weekly program for kids living in low-income housing, we are able to invest in our local community and share the love of Christ.
