These screenings are not billed to insurance. Another Avera St Mary's program that benefits Goal 2 is the Rural Health Care Coordination grant through HRSA. The purpose of this grant is to develop health networks in rural locations to address chronic conditions. Avera St Mary's chose to focus on diabetic outreach. Since the grant was received in September 2015, outreach has been done in Gregory, SD, Winner, SD and Miller, SD. The goal of the grant was to enroll 35 patients in the program, there are currently 40 patients enrolled. These 40 patients have experienced a 2 point reduction in their HbA1C levels, 22% improvement in dilated eye exams and 11% improvement in diabetic foot exams. Goal 3 Avera St Mary's is continually attempting to recruit a Psychiatrist to join the team, but as of the end of the tax year, no leads have been identified. Avera St Mary's had a visiting physician from Avera St Luke's coming on campus once a month, but unfortunately his services ended in November 2016. Avera St Mary's continues to employ Julie Cox CNP, that is dedicated to behavioral health. Ms. Cox became an Avera St Mary's employee on 8/1/14. During FY2017, she saw 965 patients.
