We save time and effort for Architects, Engineers, Government agencies, etc. by publicizing their projects to a much broader audience. CIC provides a library of blueprints (that are available to contractors to be copied) and acts as a central location for prime contractors, subcontractors, material suppliers, etc. to connect to provide for optimal competitive pricing on a given construction project. This benefits the industry and the public by constructing better buildings for less money.

CIC provides information on competitive bidding opportunities. CIC researches and compiles information on bidding opportunities (private, public, governmental) and disseminates it back out to the membership through a weekly publication.
