Safe Harbor staff can be contacted via telephone 24 hours a day, 7 days a week, 365 days a year. The Organization shelters victims and children of domestic violence for a temporary period of time while they are looking for a new, safe place to live. The Organization also provides advocacy services for victims of domestic violence, sexual assault, bullying, and stalking. In FY2017, Safe Harbor assisted 1558 women, children and men that were victims of domestic violence. Safe Harbor also assisted 237 stalking victims, 65 sexual abuse victims, 13 adolescent sexual abuse victims, 26 child abuse victims, 64 domestic violence protection orders, and 26 stalking protection orders. The Organization sheltered 51 women and 51 children, providing 3,189 bed nights and 9,567 meals.

Kids Konnection served as a supervised visitation and exchange center for individuals referred by a court system, Department of Social Services, attorneys or others if there are difficulties exchanging children with another caretaker including when a court order restricts contact between parents or emotional safety is compromised. The Office Manager is reviewed by the Executive Director and this information is then given to the Board of Directors. The Executive Director researches comparable salaries with similar domestic violence shelters and makes suggestions to the Board of Directors of raises, the budget is reviewed, the Board of Directors then votes and is documented in the Board minutes.
