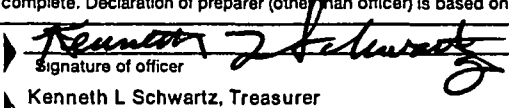

The Richardson East Rotary Foundation was organized to facilitate its sponsor organization, the Richardson East Rotary Club, to develop the mission of Rotary which is to encourage and foster its individual members in: 1) the development of acquaintance as an opportunity for service; 2) develop high ethical standards in business and professions, recognize the worthiness of all useful occupations, dignify each member's occupation as an opportunity to serve society; 3) apply the Ideal of service in each Rotarian's personal, business and community life and 4) advance the international understanding, goodwill and peace through a world fellowship of business and professional persons through service to our fellow man.

Form 990-EZ, Part III, Line 28 - Community Service Program Accomplishments

Community Service to the Richardson, TX community was provided by supplying financial support to the City of Richardson needed to build an new all-inclusive park for it's residents and members of the larger community. Our Club and Foundation committed to raise a minimum of \$250,000 toward the construction and equipping of the park. Most of the funding is to be raised during the Foundation's 2017-2018 fiscal year. In addition, the Foundation provided \$17,750 of payments to current and prior year scholarship recipients and approximately \$20,500 to various other local 501(c)(3) organizations who support the Richardson community with educational, literacy, dental and social programs.

This Foundation partnered with The Rotary Foundation (RF), an affiliated 501(c)(3) organization located in Chicago, IL by supplying \$8,525 in cash funds. The RF operates world-wide and supports a variety of humanitarian projects such as literacy, polio eradication, world peace and water and sanitation projects in undeveloped countries. All projects involving this Foundation are undertaken in partnership with a Rotary club in the country in which the project is located. The Rotary system allows our sponsor club to partner with Rotarians in other Rotary clubs throughout the world by assisting the foreign partner club in providing sometimes urgently needed programs and facilities to their friends and neighbors. Needless to say, the accomplishment of these projects results in mutual goodwill for the participating clubs and their respective members which helps in the promotion of Rotary's goal of peace, goodwill and international understanding.
