The Lovepacs single program's purpose is to help mitigate the negative impact inadequate nutrition has on the health and well-being of children and their ability to learn by providing nutritionally balanced, child-friendly food items on the extended breaks when school is not in session and they are unable to access school provided meals. Food is sent home in marked boxes during the break to provide nourishment for the extended break. During the 2016-2017 school year, Lovepacs served over 360,000 meals to an estimated 4,100+ children in 96 public schools in The State of Texas during the school year and summer.
