In fulfilling its mission of investigating, documenting and reporting incidents of anti-Semitism on college campuses, AMCHA Initiative tracked antisemitic incidents on university campuses across the country through monitoring media sources, social media accounts, and student reported incidents of campus antisemitism. The incidents were documented and reported on the AMCHA website in Student Voices and Campus Monitor Pages that tracked swastikas and other antisemitic graffiti, disruptions of Jewish student events, actions that promoted divestment from Israel, and faculty who publicly supported the boycott of Israel academic and cultural institutions. AMCHA also launched a set of interactive maps showing the geographic distribution of antisemitic activity across 163 university campuses across the country. AMCHA's Antisemitism Trackers documented nearly 500 incidents of antisemitic activity on 163 campuses in the year to date overall. The data about The Impact of Academic Boycotters of Israel on U.S. Campuses were compiled, analyzed, interpreted and released in a recent report in order to inform the public of the extent to which BDS-supporting faculty engage in anti-Zionist activism on their campuses and what harm this causes to Jewish students. Data revealed that the greater the number of faculty boycotters in a department, the greater the number of outside BDS proponents brought to campus by that department, and the greater the likelihood of incidents of anti-Jewish hostility on campus. The study showed that even advocating for a boycott of Israel as part of a department's sponsorship of BDS-supporting speaker-events is significantly associated with acts that target Jewish students for harm, including assault, harassment, destruction of property, and suppression of speech. It additionally revealed startling insights into Middle East Studies, Ethnic Studies and Gender Studies and these departments' relationship to BDS. The study was reported upon by The Jerusalem Post, The Washington Free Beacon, Algemeiner, Legal Insurrection, Jewish Press, Baltimore Jewish Life, Arutz Sheva, San Diego Jewish World and many others.
