Additional efforts were directed towards researching potential grant opportunities and preparing grant applications for grants to be awarded in FY 2018. In FY 17, Southwest Tech was able to award 7 Merit based, 1 leadership based and 17 needs based scholarships to students that otherwise would not be able to obtain post secondary education. These scholarships were made possible by SWATC Foundation fundraising.
