College Prep - A year-long program that guides high school seniors through the entire college search and application process through a weekly 2-hour workshop. Each senior is paired with an individual coach who meets with the student as needed to help guide the student through the application process. Once the application has been submitted and the student has been accepted, college coaches then work with the student to apply for FAFSA funding and search and apply for scholarships. In April students work with their coach to compare financial aid and funding packages to make an informed decision about the college they will attend in the fall. In 2016-17, 100% (53 students) of our high school seniors graduated from high school. Of these 53, 96% committed to college and/or career training. 32 left to attend a 4-year college, 19 attended community college, 1 enlisted in the U S Marine Corps, and 1 remained undecided upon high school graduation.

Form 990, Part III, Line 4b:

Here to There - The first step on a Future 5 student's path to success. Here to There is our entry-level, character-building workshop available to high school students and a requirement for membership at Future 5. Students meet weekly for a 6-week workshop to define and discuss their goals and the obstacles ("gremlins") that stand in the way of reaching them. How do you get from "here" to "there"? Working in small groups, students and coaches discuss specific steps the students can take to remove or navigate around the obstacles. Weekly theme topics include Commitment, Success, Grit/Resilience, and Asking for Help. Commitment is a central theme throughout Here to There - commitment to yourself, your success, as well as commitment to Future 5. At the completion of Here to There, students and coaches meet individually to complete a Game Plan for Life, a document that outlines our student's goals (short term and long term) and the steps the student has agreed to take in order to make his/her goals a reality. Students are welcomed as full members of Future 5 upon completion of Here to There and eligible to participate in College Prep, Job Prep, Community Service, and receive academic tutoring. Game Plans are reviewed throughout the years a student is an active member of Future 5.

Form 990, Part III, Line 4c:

Job Prep - A weekly workshop that meets January thru April that focuses on "soft skills" (handshake, eye contact, first impression), 'elevator pitch," career exploration, mock interviews, conflict resolution, resume preparation, job application and follow up procedures. In April, Job Prep students attend job shadowing events and site visits at local companies. Coaching is primarily done in small groups with 3-4 students per coach for a variety of role-playing scenarios. Students who complete Job Prep are given business cards, a letter of recommendation, and copies of their resumes. In 2016-17, 14 students completed the requirements for Job Prep and participated in site visits to The Ashforth Company, XL Catlin, and Nielsen.
